RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 1 CY 2016 OF BARANGAY CAMPAASAN AMOUNTING TO ONE MILLION TWO HUNDRED FIVE THOUSAND TWO HUNDRED FIFTY TWO PESOS AND THIRTY TWO CENTAVOS (PHP1,205,252.32) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 16-12-02 DATED DECEMBER 3, 2016

RESOLVED AS IT IS HEREBY RESOLVED, To: Approve Supplemental Budget No. 1 CY 2016 of Barangay Campaasan amounting to One Million Two Hundred Five Thousand Two Hundred Fifty Two Pesos and Thirty Two Centavos (Php1,205,252.32) passed under Sangguniang Barangay Appropriation Ordinance No. 16-12-02 dated December 3, 2016 with the following recommendations, to wit:

1. That, the procurement of supplies and materials is in accordance with RA 9184 (Government Procurement Reform Act);
2. That, the disbursement of fund shall be in accordance with COA Rules and Regulations;
3. That, the Sangguniang Barangay of Campaasan is likewise advise to strictly follow the recommendation of the Local Finance Committee as reflected in the review letter attached herewith;
4. That, compliance with all existing and applicable laws, rules and regulations shall be the sole responsibility of the Sangguniang Barangay of Campaasan in connection with the implementation of said appropriation ordinance.


