**"WHEREAS**, the Department of Trade and Industry under the DTI's Livelihood Seeding Program-Negosyo Serbisyo sa Barangay (LSP-NSB) will be distributing livelihood kits to qualified Micro, Small and Medium Enterprises (MSMEs) to support and promote MSMEs and aspiring entrepreneurs;
