**“WHEREAS**, the Doctor to the Barrio-Center for Health Development (DOH-CHD) is a DOH program aimed to promote health consciousness in rural communities and to deliver various medical services to remote and far-flung barangays;

**“WHEREAS**, it had been proven in the past that rural medical services rendered by the program “Doctor to the Barrio” was of great help in alleviating health condition of the rural communities giving them access to immediate medical needs and services;

**“WHEREAS**, the deployment of one (1) Doctor to the Barrio in the person of Dr. Jannelyn P. Orpilla detailed in Barangay Benli Mini-Hospital, Bulalacao, Oriental Mindoro was truly a big help to the residents which is composed of one hundred percent hanunuo mangyans who are prone to malaria, dengue and filariasis because various medical programs were introduced to arrest these contagious diseases that endanger lives of our brothers and sisters living in the hinterland;

"WHEREAS, it is understood that the contract of service of the Doctor to the Barrio is only for two (2) years where Dr. Orpilla shall end her service in October 2017, this resolution is passed for the DOH information and reference so that another doctor shall be deployed for the continuance of the health programs and activities that were initiated by his predecessor; Now, therefore, be it


