RESOLUTION NO. 16-09-119

REQUESTING THE LAND BANK OF THE PHILIPPINES, ROXAS AND PINAMALAYAN BRANCHES TO ASK FOR A COPY OF THE BARANGAY ANNUAL BUDGET REVIEWED AND APPROVED BY THE SANGGUNIANG BAYAN BEFORE WITHDRAWAL OF ANY FUND BE ALLOWED BY THE BANK

"WHEREAS, Section 57 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that within ten (10) days after its enactment, the sangguniang barangay shall furnish copies of all barangay ordinances to the sangguniang bayan concerned for review whether the ordinance is consistent with law or municipal ordinance;

"WHEREAS, par (i), Section 447 of the same law states that the Sangguniang Bayan shall review all ordinances approved by the Sangguniang Barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

"WHEREAS, guided with the laws mentioned herein, the Sangguniang Bayan of Bulalacao, Oriental Mindoro is appealing to the Land Bank of the Philippines, Roxas and Pinamalayan Branches to strictly ask for a copy of the Barangay Annual Budget of all barangays comprising this Municipality before they shall be allowed to withdraw from their deposits in order to ensure that funds withdrawn shall be solely used for the programs and projects appearing in their prepared and approved barangay budgets;

"WHEREAS, this resolution was prompted by past experiences of certain barangays in Bulalacao wherein they made various withdrawals from LBP without submission of their annual budget to the Sangguniang Bayan for review and approval resulting to manipulation and juggling of funds to the detriment of the constituents who are deprived of the benefits emanating from the proposed programs and projects enumerated in the budget; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Land Bank of the Philippines, Roxas and Pinamalayan Branches to ask for a copy of the Barangay Annual Budget reviewed and approved by the Sangguniang Bayan before withdrawal of any fund be allowed by the bank;


