RESOLUTION NO. 17-02-041

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2017 OF BARANGAY CABUGAO, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF ONE MILLION FIVE HUNDRED FORTY THOUSAND AND TWO PESOS (PHP1,540,002.00) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 2015-002 DATED SEPTEMBER 2, 2016

“WHEREAS, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

“WHEREAS, the Sangguniang Barangay of Cabugao, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 2017 showing therein the sources of income and barangay expenditures starting from January 1, 2017 up to December 31, 2017;

“WHEREAS, the Barangay Fund Annual Budget for FY 2017 of Barangay Cabugao was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on February 10, 2017 and was found to be consistent and in accordance with the priority developments projects of the barangay with the advice that all projects funded under the 20% Development Fund be implemented and should not be realigned to any other projects;

"WHEREAS, Sangguniang Barangay of Cabugao, Bulalacao, Oriental Mindoro is likewise advise to strictly follow the recommendation of the Local Finance Committee as reflected in the review letter attached herewith;

"WHEREAS, pursuant to Republic Act No. 7160 otherwise known as the Local Government Code of 1991, the Plantilla of Personnel in the Sangguniang Barangay includes the Punong Barangay as the Regular Presiding Officer and the Sangguniang Barangay Members so that this Sanggunian recommends to make the necessary adjustments thereof;

"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing COA rules and regulations, Now, therefore, be it;

RESOLVED AS IT IS HEREBY RESOLVED, To: Approve the Barangay Fund Annual Budget for FY 2017 of Barangay Cabugao, Bulalacao, Oriental Mindoro, appropriating the amount of One Million Five Hundred Forty Thousand and Two Pesos (PhP1,540,002.00) passed under Sangguniang Barangay Appropriation Ordinance No. 2015-002 dated September 2, 2016;






