### RESOLUTION NO. 21-02-081

EARNESTLY REQUESTING HONORABLE HUMERLITO "BONZ" A. DOLOR, PROVINCIAL GOVERNOR, PROVINCE OF ORIENTAL MINDORO TO FAVORABLY ENDORSE AND SUPPORT THE RESOLUTION NO. 21-02-076 ENTITLED "EARNESTLY REQUESTING HIS EXCELLENCY RODRIGO ROA DUTERTE, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO FACILITATE THE IMMEDIATE DOWNLOADING OF THE PHP80M WORTH OF PROJECTS FROM THE NTF-ELCAC AND FURTHER REQUESTING THAT THESE PROJECTS BE IMPLEMENTED AND MANAGED BY THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO"

"WHEREAS, Article II of the 1987 Constitution provides that the Philippine renounces war as an instrument of national policy. The maintenance peace and order, the protection of life, liberty and property and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy. The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living and an improved quality of life for all;

"WHEREAS, to effectively address the Communist Terrorist Group (CTG) problem, the government has entered into a massive campaign to spur the development of the rural countryside so that barangays impoverished by the malignant presence of the CTG can also experience the sustainable growth being enjoyed by the communities who were able to expel them;

"WHEREAS, government agencies and their corresponding units at all levels cooperate, interact, support, provide practical solutions and solve problems and issues on the ground that are being exploited by these communist terrorists in order to stir-up the people to fight against our government through armed struggle;

**"WHEREAS**, Executive Order No. 70 signed in December 2018 created the National Task Force to End Local Communist Armed Conflict (NTF-ELCAC) institutionalized a whole of nation approach in obtaining exclusive and sustainable peace giving as an effective solution against communist terrorists;

**"WHEREAS**, the Local Government of Bulalacao, Province of Oriental Mindoro supports the mission of NTF-ELCAC that will hopefully put an end to its treacherous life cycle through barangay empowerment and transparency so that there will be no reason for the Communist Party of the Philippine to agitate, organize and mobilize the vulnerable sectors and communities;

**"WHEREAS**, the Municipality of Bulalacao, Province of Oriental Mindoro is an advocate and beneficiary of KALAHI-CIDDS Program as provided by Municipal Ordinance No. 20-11-279 entitled "An ordinance institutionalizing and adopting the Municipal Community Driven Development Program (MCDDP) in the Municipality of Bulalacao, Oriental Mindoro; appropriating funds, providing exemptions and for other purposes" and identified Barangays of Benli, Milagrosa, Nasucob and San Isidro as first beneficiaries of NTF-ELCAC funds;

**"WHEREAS**, it is also the policy of the Local Government Unit of Bulalacao to empower the Barangays by allowing them to implement the government projects in order to instill the principle of co-ownership; **Now, therefore, be it**
