**RESOLUTION EARNESTLY REQUESTING REPRESENTATIVE ALFONSO V. UMALI JR, SECOND DISTRICT, ORIENTAL MINDORO, TO PROVIDE THE NECESSARY INTERVENTION FOR THE ALLOCATION OF 129 SCHOLARSHIP SLOTS UNDER THE TERTIARY EDUCATION SUBSIDY (TES) PROGRAM OF THE COMMISSION ON HIGHER EDUCATION (CHED) FOR ALL ENROLLEES AT MINDORO STATE COLLEGE OF AGRICULTURE AND TECHNOLOGY (MINSCAT) BONGABONG CAMPUS-BULALACAO EXTENSION CLASSES**

**"WHEREAS,** Commission on Higher Education is the national government agency in-charged on promoting relevant, accessible, and quality higher education that guarantees and protects academic freedom for continuing intellectual growth, advancement of learning and research, development of responsible and effective leadership, education of high level professionals and enrichment of historical heritage;

**"WHEREAS,** Mindoro State College of Agriculture and Technology (MinSCAT), a state college that has equipped its students with quality education for them to become competent professionals who can significantly contribute to their chosen fields, has extended its services to Bulalacao thru the establishment of MinSCAT Bongabong Campus-Bulalacao Extension Classes;

**"WHEREAS,** Bulalacao, a third class municipality located at the southernmost tip of Oriental Mindoro with a population of 39,107 based on 2015 census, 25 percent of which are indigenous people called Hanunuo Mangyan, has a municipal government that promotes, upholds, and supports "Education for All" advocacy;

"WHEREAS, MinSCAT Bongabong Campus-Bulalacao Extension Classes, barely three (3) years in operation, desires to increase enrollment by means of offering scholarship grant to poor but deserving youth most especially those who belong to Hanunuo Mangyan tribe and those who are out-of-school youth;

"NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to request Representative Alfonso V. Umali Jr, Second District, Oriental Mindoro to provide the necessary intervention for the allocation of 129 scholarship slots under the Tertiary Education Subsidy (TES) Program of the Commission on Higher Education (CHED) for all enrollees at MinSCAT Bongabong Campus-Bulalacao Extension Classes.
