RESOLUTION NO. 18-11-256

EARNESTLY REQUESTING THE DEPARTMENT OF HEALTH, REGIONAL OFFICE THROUGH DR. EDUARDO C. JANAIRO, REGIONAL DIRECTOR, TO ALLOCATE THE AMOUNT OF TEN MILLION PESOS (PhP10M) TO BE USED FOR THE CONSTRUCTION OF A BUILDING WHICH SHALL SERVE AS AN EXPANSION OF THE MUNICIPAL HEALTH OFFICE IN THE LOT OWNED BY THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO ADJACENT TO THE BUREAU OF FIRE PROTECTION

"WHEREAS, the Municipality of Bulalacao is located in the southernmost tip of the Province of Oriental Mindoro whose population is composed of approximately 20% hanunuo mangyan who because of poverty could hardly meet the needed medical care;

"WHEREAS, the present Administration aware of the basic needs of its constituents particularly those pertaining to health care and services exerted extra efforts to source out funds from the higher government agencies to provide its people with the opportunity to enjoy the benefits as provided by the constitution;

"WHEREAS, the present Municipal Health Office needs to be expanded to accommodate its increasing patients everyday who need immediate care and attention however, it could not be readily provided within its premise due to limited space; **Now, therefore, be it**


RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Department of Health, Regional Office through Dr. Eduardo C. Janairo, Regional Director to allocate the amount of Ten Million Pesos (PhP10M) to be used for the construction of a building which shall serve as an expansion of the Municipal Health Office in the lot owned by the Municipality of Bulalacao, Province of Oriental Mindoro adjacent to the Bureau of Fire Protection;
