EARNESTLY REQUESTING THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB), REGIONAL OFFICE THRU DIRECTOR GUALBERTO N. GUALBERTO TO GRANT SPECIAL PERMITS TO DEL MONTE LAND TRANSPORT BUS COMPANY (DLTBCO) INC., AND OTHER INTERESTED BUS COMPANY FROM 30 DAYS TO 120 DAYS FOR THEIR FIFTY (50) BUSES TO OPERATE FROM OCCIDENTAL AND ORIENTAL MINDORO GOING TO MANILA AND VICE VERSA ROUTES WHILE WAITING FOR THE APPROVAL OF ITS FRANCHISE

“WHEREAS, public transportation improves the quality of life in communities across the country by providing safe, efficient and economical service. It also serves as a vital component necessary for a healthy economy. Not only does public transit benefit the people who use it but it also benefits society as a whole;

“WHEREAS, as a result of preventive suspension of several public transportation vehicles, the riding public particularly from Occidental and Oriental Mindoro suffered inconvenience and difficulties doing their daily activities such as going to work, students daily schooling is badly affected so that there is an urgent need to provide a supplemental transportation service which could cater the passengers of the two provinces mentioned herein;

“WHEREAS, Del Monte Land Transport Bus Company (DLTBCO) Inc., is manifesting its desire to temporarily serve the passengers from Occidental and Oriental Mindoro to Manila and vice versa routes through a special permit that shall be issued by the LTFRB until its franchise be finally approved and released by the latter; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED To: Earnestly request the Land Transportation Franchising and Regulatory Board (LTFRB), Regional Office thru Director Gualberto N. Gualberto to grant special permits to Del Monte Land Transport Bus Company (DLTBCO), Inc. and other interested bus company from 30 days to 120 days for their fifty (50) buses to operate from Occidental and Oriental Mindoro going to Manila and vice versa routes while waiting for the approval of its franchise;




