REQUESTING THE LAND BANK OF THE PHILIPPINES THRU ITS PRESIDENT AND CHIEF EXECUTIVE OFFICER, MS. CECELIA C. BORROMEO TO INSTALL ONE (1) UNIT OF CASH DEPOSIT MACHINE (CDM) TO THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO IN THE ABSENCE OF ANY COMMERCIAL OR GOVERNMENT BANK IN THIS MUNICIPALITY

“WHEREAS, the Cash Deposit Machine (CDM) is a self-service terminal that lets you make deposits and payment transactions by cash round the clock;

“WHEREAS, with the Cash Deposit Machine, you no longer have to wait to deposit money during banking hours using deposit slip and you will no longer take a long queues at ATM to withdraw money;

“WHEREAS, the provision of Cash Deposit Machine in Bulalacao, Oriental Mindoro is timely and direly needed because of the absence of a commercial or government bank in the locality; the nearest Land Bank of the Philippines, Roxas Branch will take one and a half hours of travel;

“WHEREAS, the Cash Deposit Machine in Bulalacao shall cater thousands of employees both from the government and private sectors including the business sector, local and foreign tourists, the Overseas Filipino Workers, visitors and guests, students and all other government daily financial transactions, all these shall be made easier and economical; **Now, therefore, be it**






