**RESOLUTION REQUESTING HIS EXCELLENCY RODRIGO ROA DUTERTE THROUGH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT OFFICE, REGION IV-MIMAROPA TO FACILITATE THE IMMEDIATE RELEASE OF UNCONDITIONAL CASH TRANSFER FOR THE SENIOR CITIZENS OF BULALACAO, ORIENTAL MINDORO STARTING FROM THE YEAR 2018 UP TO THE PRESENT**

**“WHEREAS**, the Unconditional Cash Transfer (UCT) is the subsidy under the Tax Reform for Acceleration and Inclusion or TRAIN Law provided to give assistance to the indigent senior citizens who are sick and disabled;

**“WHEREAS**, qualified beneficiaries of UCT are those who are frail, sick, with disability, without pension and no permanent source of income, compensation or financial support from relatives;

**“WHEREAS**, based on records of the Municipal Social Welfare and Development Office of the Municipality of Bulalacao, Oriental Mindoro, there are 2,148 identified as indigent senior citizens who are qualified to receive the unconditional cash transfer which aims to cushion the impact of the new tax reform law on poor Filipinos;

**“WHEREAS**, it sad to know that 100% of these beneficiaries did not receive yet the UCT since its implementation in 2018 according to the records of the MSWDO which brought dismay to the senior citizens of this Municipality who felt betrayed of this valuable benefits due to them; **Now, therefore, be it**


