"WHEREAS, the LCPC Work and Financial Plan for 2023 and the LCAT-VAWC consist of programs and activities, the time frame and funds identified by the councils to be of utmost priorities in its efforts to safeguard and advocates for the welfare of the children and to eradicate violence against women and children in the locality;
