PRIORITIZE THE BULALACAONON TEACHERS IN GRANTING ITEMS
FOR TEACHING IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF

"WHEREAS, Section 1 of Republic Act No. 8190 states that in the appointment or assignment of teachers to public elementary or secondary schools, priority shall be given to bona fide residents of the barangay, municipality, city or province where the school is located: Provided, That the teacher possesses all the minimum qualifications for the position as required by law;

"WHEREAS, Bulalacao is 3rd class municipality hounded with financial constraints, has a municipal government that promotes, upholds, and supports "Education for All" advocacy, the updated number of schools within the municipality are 46 elementary schools including extensions and 22 high schools including extensions, and consistently hiring 120-150 municipal-funded teachers every year;

"WHEREAS, in the Registry for Qualified Applicants for S.Y. 2023-2024, there are a total of more than 100 hopeful Bulalacaonon teachers for elementary and secondary high school who applied and became eligible for the ranking to the hiring of Teacher I positions in Bulalacao District;

“WHEREAS, in the previous administration of the School Division Office of Oriental Mindoro, many teachers from adjacent municipalities got hired in Bulalacao instead of its bona fide residents, auspiciously, with the return of School Division Superintendent, Dr. Maria Luisa D. Servando, there is a high hope of consideration for Bulalacaonon teachers to get prioritized in the hiring process;

“WHEREAS, this Sanggunian is humbly asking Congressman Alfonso V. Umali, Jr. to use his influence to convince the School Division Superintendent, Dr. Maria Luisa D. Servando to prioritize the Bulalacaonon teachers in granting items for teaching in their own municipality; Now, therefore, be it...






