#### RESOLUTION APPROVING THE 2024 ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

**WHEREAS**, Section 106 of the Local Government Code of 1991 states that each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian. For this purpose, the development council of the municipality shall assist the corresponding sanggunian in setting the direction of economic and social development and coordinating development efforts within its territorial jurisdiction;

**WHEREAS**, on April 26, 2023, the Municipal Development Council (MDC) composed of all punong barangay, representatives of non-governmental organizations together with the concerned municipal officials convened in order to formulate the Annual Investment Program, CY-2024 to achieve the Municipality's mission of establishing an efficient local legislation responsive to the needs of the locality and effectively manages its resources to sustain growth and development to achieve the vision of a "Beautiful and Bountiful Bulalacao";

**WHEREAS**, the 2024 Annual Investment Program is aligned with the provincial, regional and national development thrusts. The AIP for CY 2024 undergone a careful processes consisting of review and assessment of the status of projects implemented in the preceeding year, consultation and workshop with various sectors and barangay officials, cross-sectoral integration activities and

strategic planning workshop in order to address the priority needs mentioned under social services, economic services, general public services, other services sector and environmental development sector with a total amount of PhP8,069,459,420.76;

**WHEREAS**, the AIP is the basic document linking the local development plan to the budget of the Municipality for the current year and contains prioritized list of Programs, Projects and Activities (PPAs) which were culled from the LDIP matched with the financing resources to be implemented within a year;


