SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HONORABLE ARTHUR C. YAP, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) FOR THE GRANT OF THE NECESSARY AMOUNT OF THE LATTER TO THE FORMER TO BE USED FOR THE CONSTRUCTION/ REHABILITATION OF BARANGAY BENLI PROPER-SITIO BAILAN-SITIO UMABANG FARM TO MARKET ROAD, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO


