SPECIAL ORDINANCE NO. 10-02-31

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HONORABLE NASSER C. PANGANDAMAN, SECRETARY, DEPARTMENT OF AGRARIAN REFORM (DAR) FOR GRANTING THE AMOUNT OF TEN MILLION PESOS (PHP10M) TO THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF FARM TO MARKET ROAD FROM SITIO BANGKAL, BARANGAY SAN JUAN TO BARANGAY SAN ROQUE, THIS MUNICIPALITY AND RATIFYING THE SAME CONTRACT

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The Municipal Mayor, the Honorable Emilo C. Villas is hereby authorized to enter into a Memorandum of Agreement with the Honorable Nasser C. Pangandaman, Secretary, Department of Agrarian Reform (DAR) for granting the amount of Ten Million Pesos (Php10M) to the Municipality of Bulalacao, Oriental Mindoro to be used for the construction/rehabilitation of Farm to Market Road from Sitio Bangkal, Barangay San Juan to Barangay San Roque; and to ratify the same contract;
