SPECIAL ORDINANCE NO. 12-11-24

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH MR. DANNY M. CERVAS GRANTING THE LATTER THE EXCLUSIVE RIGHTS TO OPERATE THE PARKING AREA FOR FEE SITUATED IN BARANGAY CAMPAASAN, BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The Municipal Mayor, the Honorable Ernilo C. Villas is hereby authorized to enter into a Memorandum of Agreement with Mr. Danny M. Cervas granting the latter the exclusive rights to operate the parking area for fee situated in Barangay Campaasan, Bulalacao, Oriental Mindoro;

SEC. 2. This Special Ordinance shall take effect immediately.
