ORDINANCE NO. 14-05-141-A

AN ORDINANCE ADOPTING THE MARINE PROTECTED AREAS MANAGEMENT PLAN OF BULALACAO, ORIENTAL MINDORO, 2014-2015

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao,
Oriental Mindoro:

SECTION 1. In order to meet the objectives of Marine Protected
Areas of the Municipality of Bulalacao, Province of Oriental Mindoro,
particularly the following:

- a. the creation of an organized group of fisherfolks that shall manage the declared Marine Protected Areas;
- b. the construction of a guardhouse, acquisition of service patrol boat and provision of the necessary funds or financial assistance for the effective and efficient implementation of the Plan;
- c. to provide the necessary incentives in favor of the Bantay Dagat for the first three (3) years of the implementation; and

- d. to uplift the level of awareness of sustainable development through the environmental protection and conservation of our remaining natural resources.


The Marine Protected Areas Management Plan of Bulalacao, Oriental Mindoro, 2014-2015 is hereby adopted.


