
SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR, THE HONORABLE EDNA C VILLAS TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DILG REGIONAL DIRECTOR, REGION IV- B FOR THE IMPLEMENTATION OF DILG-PCF PROJECTS SUCH AS THE ESTABLISHMENT OF TOURISM MULTI-PURPOSE BUILDING AND THE BULALACAO DECKVIEW PARK

SEC. 2. This Special Ordinance shall take effect immediately.





