SPECIAL ORDINANCE NO. 16-09-46

SPECIAL ORDINANCE DECLARING THE REFERENCE TO ONE AND THE SAME MUNICIPALITY WHICH IS BULALACAO, ORIENTAL MINDORO, THE SOUTHERNMOST MUNICIPALITY OF ORIENTAL MINDORO, WITH THE USE OR APPEARANCE OF SAN PEDRO, BULALACAO, BULALAKAW AND BULALACAO, SILANGANG MINDORO OR ORIENTAL MINDORO IN DIFFERENT PUBLIC DOCUMENTS

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

WHEREAS, there appears in various public documents like birth, death and marriage certificates, school and institutional records, resolutions and ordinances and other public and even private papers, different names that refer to this Municipality;

WHEREAS, such references may be San Pedro, Bulalakao, Bulalakaw and Bulalacao, Silangang Mindoro or Oriental Mindoro and these names might cause confusion and misrepresentation among document users or readers;

WHEREAS, although Republic Act 5646 changed the name of this Municipality from San Pedro, Oriental Mindoro to Bulalakao, Oriental Mindoro, documents and records often mention Bulalacao, Silangang Mindoro or Bulalacao, Oriental Mindoro;

WHEREAS, proper identity of a particular municipality is most necessary in order to prevent complexities and to facilitate transactions being undertaken by its people and by all other people;

WHEREAS, it is clearly stated in the Local Government Code of 1991 that each municipal government is tasked to protect the integrity of its records and documents and to approve ordinances and pass resolutions necessary for an efficient and effective municipal government;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, That:

SECTION 1. OFFICIAL DECLARATION. The reference to one and the same Municipality which is Bulalacao, Oriental Mindoro, the southernmost Municipality of Oriental Mindoro with the use or appearance of San Pedro, Bulalakao, Bulalakaw and Bulalacao, Silangang Mindoro or Oriental Mindoro in different public documents is hereby officially declared;

SEC. 2. COMMONLY USED NAME. The use of herein cited names which refer to or describe this Municipality is hereby honored and recognized, but for the purpose of having distinct identity, it shall be encouraged that the commonly used name Bulalacao, Oriental Mindoro be adopted by all government offices and instrumentalities pending the amendment of Republic Act 5646 from Bulalakao to Bulalacao;

SEC. 3. This Ordinance shall take effect immediately.


