MUNICIPAL ORDINANCE NO. 19-10-250

AN ORDINANCE AUTHORIZING THE REIMBURSEMENT OF MONTHLY COMMUNICATION EXPENSE OF THE PUBLIC EMPLOYMENT SERVICE AND EDUCATION UNIT HEAD UNDER THE OFFICE OF THE MUNICIPAL MAYOR IN THE MAXIMUM AMOUNT OF THREE THOUSAND PESOS (PHP3,000.00)

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that

SECTION 1. STATEMENT OF POLICY. It is the policy of the Local Government Unit of Bulalacao, Oriental Mindoro (LGU of Bulalacao) to maintain empowered, high morale, and productive workforce. The Sangguniang Bayan of Bulalacao is tasked by the Local Government Code of 1991 to determine salaries, wages, allowances, and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds.

SEC. 2. ENTITLEMENT. The Public Employment Service and Education Unit Head shall be entitled to receive monthly communication expense in the maximum amount of three thousand pesos (Php3,000.00). However, if such head shall incur unauthorized absences or shall be on leave of absence for at least ten (10) calendar days, he shall not receive this benefit for the whole month. The concerned employee shall start receiving this allowance effective October 1, 2019;

SEC. 3. NON-INCLUSION IN INCREASE. Incumbent of the position stated herein shall not be covered by Php 1,000.00 across the board monthly increase of this allowance effective January 01, 2017 as mentioned in Section 3 of Special Ordinance No. 16-09-41.

SEC. 4. FUND. There shall be annual allocation for this allowance in the Office of the Municipal Mayor under communication expense budget and accounting code under the Maintenance and Other Operating Expenses.

SEC. 5. FUND DISBURSEMENT. Disbursement shall only be allowed upon presentation of statement of account or official receipt of payment for communication expense issued by legitimate retailer or dealer of communication services or products and upon certifying that the expense shall have been incurred in connection with the performance of official function.

SEC. 6. REPEALING CLAUSE. Any Ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.

SEC. 7. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect.

SEC. 8. EFFECTIVITY. This Ordinance shall take effect immediately after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.
