MUNICIPAL ORDINANCE NO. 18-02-198

AN ORDINANCE ALLOWING THE REIMBURSEMENT OF INTERNET CONNECTIVITY EXPENSE IN THE AMOUNT OF TWO THOUSAND PESOS (PHP 2,000.00) EVERY MONTH TO EACH ELECTED OFFICIAL OF THE LOCAL GOVERNMENT UNIT OF BULALACAO

Section 1. The reimbursement of an internet connectivity expense amounting to two thousand pesos (PhP 2,000.00) every month shall be granted by the Local Government Unit of Bulalacao to each elected official of the same agency effective January 1, 2018.

Section 2. The municipal mayor, municipal vice mayor, and all sangguniang bayan members including the ex-officio members shall be entitled to such reimbursement.

Section 3. The funding requirement for this expense for the fiscal year 2018 shall be taken from savings in maintenance and other operating expenses (MOOE) of the same fiscal year. There shall be yearly appropriation for this expense under the MOOE of Office of the Municipal Mayor and Sangguniang Bayan.

Section 4. Disbursement shall only be allowed upon presentation of statement of account or official receipt of payment for internet subscription expense issued by legitimate retailer or dealer of communication services or products.

Section 5. Any ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.
