AN ORDINANCE RECOGNIZING ALL FORMER LIVING BARANGAY OFFICIALS IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO BY AWARDING THEM PLAQUE OF RECOGNITION AND GRANTING CASH INCENTIVES IN THE AMOUNT OF TWO THOUSAND PESOS (Php2,000.00) EACH AS A TOKEN OF APPRECIATION FOR THEIR TIRELESS EFFORTS AND DEDICATION IN THE EFFECTIVE PERFORMANCE OF THEIR DUTIES AND FUNCTIONS

"WHEREAS, Chapter 2, Section 387 states that "There shall be in each barangay a punong barangay, seven (7) sangguniang barangay members the sangguniang kabataan chairman, a barangay secretary and a barangay treasurer;

"WHEREAS, pursuant to Section 393 of the same law mentioned above, barangay officials shall receive honoraria, allowances and such other emoluments as may be authorized by law or barangay through an ordinance in accordance with the provisions of this Code;

"WHEREAS, as a token of appreciation for their meaningful, dedicated and long years of public service, this Sanggunian believed that it is just proper to extend financial assistance to them in the amount of two thousand pesos (PhP2,000.00) each; **Now, therefore, be it RESOLVED AS IT IS HEREBY RESOLVED To:** Enact an Ordinance recognizing all former living barangay officials in the Municipality of Bulalacao, Oriental Mindoro by awarding them Plaque of Recognition and granting cash incentives in the amount of two thousand pesos (PhP2,000.00) each as a token of appreciation for their tireless efforts and dedication in the effective performance of their duties and functions;

SECTION 1. All former living barangay officials in the Municipality of Bulalacao, Oriental Mindoro are hereby awarded Plaque of Recognition and granted cash incentives in the amount of two thousand pesos (PhP2,000.00) each as a token of appreciation for their tireless efforts and dedication in the effective performance of their duties and functions;

SECTION 2. Funds for the implementation of this Ordinance shall be taken from Award/Reward Expense under the Office of the Municipal Mayor.

SECTION 3. This Ordinance shall take effect immediately.


