**REQUESTING THE SANGGUNIANG BAYAN OF MAGSAYSAY,
OCCIDENTAL MINDORO TO CONDUCT A JOINT SESSION WITH THE
SANGGUNIANG BAYAN OF BULALACAO, ORIENTAL MINDORO TO
DISCUSS ISSUES AND CONCERNS REGARDING WATER DELIENATION
BETWEEN THE TWO MUNICIPALITIES**

"WHEREAS, Section 131 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 defines that "Municipal Waters" includes not only streams, lakes and tidal waters within the national parks, public forest, timber lands, forest reserves or fishery reserves but also marine waters included between two lines drawn perpendicularly to the general coastline from points where the boundary lines of the municipality touch the sea at low tide and a third parallel line with the general coastline and fifteen (15) kilometers from it. Where two municipalities are so situated on the opposite shores that there is less than 15 kilometers of marine waters between them, the third line shall be equally distant from opposite shores of the respective municipalities;

"WHEREAS, under Republic Act 10654 or the amended Fisheries Code, municipal waters are areas covered within fifteen (15) kilometers from the coastline, including offshore islands;

“WHEREAS, a municipality can proceed with activities to delienate its municipal waters even without the guidelines from the Department of Agriculture, such is the preliminary drawing of boundaries, holding of public hearings, internal discussions and negotiations;


“WHEREAS, the delienation of municipal waters will define the geographic extent of the municipality’s taxation or revenue generating powers, it law enforcement jurisdiction, resource allocation and general management powers; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED To: Request the Sangguniang Bayan of Magsaysay, Occidental Mindoro to conduct a joint session with the Sangguniang Bayan of Bulalacao, Oriental Mindoro to discuss issues and concerns regarding water delienation between the two municipalities;


