"WHEREAS, the Enhanced KADIWA Financial Grant Assistance Program was launched by the Department of Agriculture-Agribusiness and Marketing Assistance which aims to capacitate the farmers and fisherfolk cooperatives and associations to become reliable and efficient food commodity suppliers;


“WHEREAS, Bulalacao, a third-class municipality located at the southernmost tip of the Province of Oriental Mindoro with a population of 44,366 based on 2020 census where its major sources of income are fishing and in farming, it has a municipal government that aims to promote healthful and safe mobility of people and efficient movement of goods and services by municipal wide development;


“WHEREAS, the Local Government Unit of Bulalacao, Oriental Mindoro is aiming to have hauling and delivery service vehicles to be used for different farm and marine business operations within the municipality which would be beneficial to its sectors especially the marginal members of farmer/fisherfolk associations, hence, it would be needing support from the Department of Agriculture thru its KADIWA Financial Grant Assistance Program for its affirmative procurement; Now, therefore, be it...

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request the Department of Agriculture to allocate funds in the amount of Five Million Pesos (PhP5,000,000.00) thru its KADIWA Financial Grant Assistance Program to be used for the procurement of 1 unit of hauling truck and 2 units of L300 van delivery service intended for famers/fisherfolks and processors of the Municipality of Bulalacao, Province of Oriental Mindoro,
