"WHEREAS, it is the declared policy of the State to achieve sustainable modern agriculture and food security by helping the agricultural and fishing communities to reach their full potential, increasing farmers' and fishermen's incomes, and bridging gap's through public-private partnerships thereby improving their quality of life;

"WHEREAS, in recognition of the significant role of agriculture in the economic system, Republic Act No. 11321 also known as Sagip Saka Act was put into law which aims to strengthen farmers and fisherfolks by extending help to agriculture and fishing communities, including the grant of tax incentives and exemptions;

"WHEREAS, apart from incentives for the private sector, the Sagip Saka Act signed into law in 2019 authorizes all government offices and local government units to directly buy goods and produce from farmers and fisherfolk cooperatives by passing the complicated and time-consuming bidding process. This will surely help increase the income of farmers and fishermen because Sagip Saka Act do away with middlemen;

"WHEREAS, full implementation of Sagip Saka Act will cushion the impact of oil price hikes in the agricultural sector which would encourage higher agricultural production, increase supply in the market and effectively lower food prices for the benefits of the Filipino people; **Now, therefore, be it**






