AN ORDINANCE GRANTING MONTHLY ALLOWANCE TO THE
 MUNICIPAL POLICE STATION PERSONNEL INCLUDING ITS NON-
 UNIFORMED PERSONNEL IN BULALACAO, ORIENTAL MINDORO AND
 APPROPRIATING FUNDS THEREFOR

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental
 Mindoro:

Section 1. Statement of Policy. It is the policy of the Local Government Unit of Bulalacao, Oriental Mindoro to maintain empowered, high morale, and productive workforce. The Sangguniang Bayan of Bulalacao is tasked by the Local Government Code of 1991, when the finances of the municipal government allow to provide for additional allowances and benefits to judges, prosecutors, public elementary and high school teachers, and other national government officials stationed or assigned to the Municipality.

Section 2. Entitlement. The personnel of the Municipal Police Station assigned in the Local Government Unit of Bulalacao including its Non-Uniformed Personnel shall be granted allowance in the amount of One Thousand Pesos (PhP1,000) every month. The highest ranking personnel or the Chief of Municipal Police Station assigned in the Local Government Unit of Bulalacao shall be granted allowance in the amount not exceeding to PhP7,000.00 every month. The personnel who shall incur unauthorized absences or who shall be on leave of absence for at least ten (10) calendar days shall not receive this benefit. The Acting Officer or In-Charge of office shall instead become the recipient until the return to office of the concerned officials.

Section 3. Requirements. Submission of the following requirements shall be required prior to the granting of allowance:

- a. Letter of intent
- b. Monthly accomplishment report

The highest ranking officer or the Chief of Police shall submit to the Municipal Treasury Office the list of the qualified personnel to obtain this allowance in a monthly manner.

Section 4. Fund. The monthly grant for this allowance shall be claimed only upon the availability of fund of the Local Government Unit of Bulalacao.

Section 5. Effectivity. This Ordinance shall take effect upon approval.
