WHEREAS, on November 7, 2022, the Sangguniang Bayan of Bulalacao, Oriental Mindoro enacted Appropriation Ordinance No. 22-11-15, Supplemental Budget No. 3 entitled, "An ordinance authorizing Supplemental Budget No. 3, series of 2022 of the Local Government Unit of Bulalacao, Oriental Mindoro involving an amount of twenty one million six hundred eighty three thousand nine hundred forty five pesos and twelve centavos (PhP21,683,945.12) for Personal Services, Maintenance and Other Operating Expenditures, Capital Outlay and certain programs and projects under the 20% Development Fund";
