
BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:


Section 1. Section 5 of Municipal Ordinance No. 22-03-313 entitled "An ordinance granting honorarium to Dr. Florecita F. Lindo, MD, MHA, Psychiatrist in the amount of ten thousand pesos (PhP10,000.00) monthly for medical services rendered to mentally challenged individual patients of Bulalacao, Oriental Mindoro is hereby amended to read as follows:

"Section 5. Effectivity. This Ordinance shall take effect starting from March 1, 2022 until the termination of her services to be determined by the Local Chief Executive upon recommendation of the Municipal Social Welfare and Development Office".


