**WHEREAS**, Municipal Environment and Natural Resources Office (MENRO) is mandated to formulate programs and activities for the conservation, protection, restoration, maintenance, utilization, promotion, enhancement and development of the ecological balance and environment of the municipality of Bulalacao, Oriental Mindoro;

**WHEREAS**, Section 26 of the Local Government Code of 1991 otherwise known as Republic Act 7160 mandates that it shall be the duty of every national agency or government-owned or controlled corporation authorizing or involved in planning and implementation of any project or programs that may cause pollution, climate change, depletion of non-renewable resources loss of cropland, rangeland, or forest cover with the local government unit, non-government organizations and other sectors concerned and explain the goals and objectives of the project or programs its impact and upon the people and the community and tenants of environmental or ecological balance and the measures that will be undertaken to prevent nor minimize the adverse effect thereof:

**WHEREAS**, in recognition of the vital role of education to foster patriotism and nationalism, accelerate social progress, promote total human liberation and development and awareness on environmental conservation and sustainability there is a need to institutionalize the celebration of Environmental Consciousness and Awareness Month in the Municipality of Bulalacao Oriental Mindoro;

**NOW THEREFORE**, be it ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in a regular session assembled, that:

**Section 1. Statement of Policy.** The Municipality of Bulalacao Oriental Mindoro recognizes the importance of public educational and awareness programs on environmental protection and conservation towards a sustainable and resilient municipality. It adheres to the principle of environmental responsibility and recognizes the importance of collaboration and partnership among Local Government Units, (LGUs) Non-Government Organization, (NGO'S) private sectors, civil society, national agencies and offices and other concerned sectors in providing a healthy environment to its constituents and to work together and harmonize all efforts towards the attainment of healthy, safe and sustainable environment and resilient community;




**Section 3. General Provisions.**


