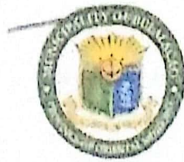

MUNICIPAL ORDINANCE NO. 24-01-377

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 15-03-147 ENTITLED "FIXING THE PRICE PER SQUARE METER OF BURIAL LOTS IN THE NEW PUBLIC CEMETERY OF BULALACAO, ORIENTAL MINDORO"

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The Section 1 of Ordinance No. 15-03-147 entitled "Fixing the price per square meter of all burial lots in the new public cemetery of Bulalacao, Oriental Mindoro is hereby amended to read as follows:

"Section 1. The price per square meter of burial lots in the new public cemetery of Bulalacao, Oriental Mindoro shall be fixed in the following manner:

- i. 1.25m x 2.5 = 3.125sq.m x PhP250.00 = PhP781.25
- ii. 2m x 4m = 8sq.m x PhP500.00 = 4,000.00
- iii. 3m x 4m = 12sq.m x PhP650.00 = 9,000.00
- iv. 4m x 4m = 16sq.m x PhP1,000.00 = 16,000.00
- v. Above 16sq.m. PhP1,250.00

All burial lots shall be renewed every five (5) years upon payment of the amount equivalent to ten percent (10%) of price of the burial lot acquired as computed in the following manner:

	Price:	Amount to be paid to renew
i.	1.25m x 2.5 = 3.125sq.m x PhP250.00 = PhP781.25	PhP78.125
ii.	2m x 4m = 8sq.m x PhP500.00 = 4,000.00	400.00
iii.	3m x 4m = 12sq.m x PhP650.00 = 9,000.00	900.00
iv.	4m x 4m = 16sq.m x PhP1,000.00 = 16,000.00	1,600.00
v.	Above 16sq.m. PhP1,250.00	

All lots shall be limited to 16 sq.m. only except those lots purchased prior to the enactment of this ordinance."

Section 2. Effectivity. This Ordinance shall take effect upon after ten (10) days of posting in at least three (3) conspicuous places in the Municipality.
