RESOLUTION NO. 84 ✓

RESOLUTION REQUESTING THE DISTRICT LAND OFFICER, BUREAU OF LANDS, ROXAS, ORIENTAL MINDORO, TO CANCEL THE LAND TITLE OF JOSE MACAYA AND SUBSEQUENT TITLES

WHEREAS, as per Resolution No. 31 dated May 30, 1970 of the Municipal Council of Bulalacao, Oriental Mindoro, six (6) hectares of land located at Campansan, this municipality was claimed by the Municipal Government, to wit: Two (2) hectares for Market site, two (2) hectares for School site and two (2) hectares for Municipal Government Sites;

WHEREAS, the Municipal Government of Bulalacao has constructed a public market building in this site since 1969 and now under operation and administration of said government, peacefully and uninterrupted;

WHEREAS, this six (6) hectares of land which was claimed by the Municipal Government was titled in the name of one Jose Macaya and now under Court litigation for annullment of title;


WHEREAS, the defunct Municipal Council of Bulalacao, likewise, had already requested the Office of the Bureau of Lands at Roxas, Oriental Mindoro the cancellation of the land title of Jose Macaya;


NOW, THEREFORE, resolved as it is hereby resolved, to request the District Land Officer, Bureau of Lands, Roxas, Oriental Mindoro, to cancel the land title of Jose Macaya Macaya and subsequent titles;




