" RESOLUTION NO. 01-02-023

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2001 OF BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF EIGHT HUNDRED FIFTY ONE THOUSAND SIX HUNDRED NINETY TWO PESOS (P851,692.00) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 02-2001 DATED JANUARY 8, 2001

"WHEREAS, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of Poblacion, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 2001 showing therein the sources of income and barangay expenditures starting from January 1, 2001 up to December 31, 2001;

"WHEREAS, the Barangay Fund Annual Budget for FY 2001 of Barangay Poblacion was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on February 12, 2001 and was found to be consistent and in accordance with the priority development projects of the barangay with the advice that all projects funded under the 20% Development Fund be implemented and should not be realigned to any other projects;


"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing COA rules and regulations; Now, therefore, be it


