RECLAIMING THE AREA OF THE RIVERBANK BEHIND THE RESIDENCES OF MIGUEL VILLAR AND SALVADOR SALAS AS CONSTRUCTION SITE OF FISHLANDING AND FISHING PORT OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, this Municipality is one area in our country that needs infrastructure support to handle fish catch in order to maximize the harvest that it gets out of its coastal area;

"WHEREAS, there is a need to reduce post harvest losses, improve the quality of produce for domestic and export consumers, enhance monetary returns of small-scale fishermen and to promote efficient packing and processing produce, hence, the necessity to construct municipal fishing port on a municipality like Bulalacao which is traditional fish collection center and transshipment point to urban markets;

"WHEREAS, with the establishment of fishing port, the government can also devised a way of effective tax collection;

NOW THEREFORE: RESOLVED AS IT IS HEREBY RESOLVED to reclaim the area of the riverbank behind the residences of Miguel Villar and Salvador Salas as construction site for fishlanding and fishing port of the municipality of Bulalacao, Oriental Mindoro;

RESOLVED FURTHER, that copies of this Resolution be furnished the Municipal Mayor, the Municipal Planning and Development Coordinator and the Municipal Agricultural Officer, Bulalacao, Oriental Mindoro for their information, ready reference and appropriate action .
