" RESOLUTION NO. 93-01-001

RESOLUTION GRANTING INCENTIVES TO THE MUNICIPAL OFFICIALS AND EMPLOYEES OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Local Treasury of Bulalacao has made a surplus of more than one million pesos (P1.m) in the previous year of 1992, due primarily to the concerted effort shared by the local government work force;

"WHEREAS, the Sangguniang Bayan of Bulalacao finds it rational to share the benefits equally to all officials and employees of the Municipal Government in order to motivate them to higher levels of performance;

"WHEREAS, the amount of one million pesos (P1.m) is certified available by the Municipal Treasurer;

NOW THEREFORE:

RESOLVED as it is HEREBY RESOLVED to grant incentives to all government officials and employees (regular and casual) of the Municipal Government of Bulalacao, Oriental Mindoro in order to motivate them to higher levels of performance;

RESOLVED FURTHER that the following be observed in the grant of incentives;

1. Regular officials and employees shall receive P 5,000.00, and;
2. Casual employees shall receive the amount ^{of} their rate per day multiplied by 22 days

RESOLVED FURTHERMORE, that only those who have rendered services before the end of December 1992 shall be entitled to this benefit;

RESOLVED FINALLY, to submit copies of this Resolution to the Municipal Treasurer for his information and guidance;
