"RESOLUTION NO. 99-05-115

EARNESTLY REQUESTING THE HONORABLE MANUEL G. ANDAYA, CONGRESSMAN, 2ND DISTRICT, ORIENTAL MINDORO TO ALLOCATE FUNDS FOR THE SALARY AND OTHER EMOLUMENTS OF ONE TEACHER IN SOON TO BE OPENED MAUJAO NATIONAL HIGH SCHOOL IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN THE AMOUNT OF TWO HUNDRED FIFTY-SEVEN THOUSAND NINE HUNDRED SEVEN PESOS AND SIXTY CENTAVOS (P215,907.60)

"WHEREAS, the 1987 Constitution provides that the State shall protect and promote the right of all citizens to quality education and shall take appropriate steps to make such education accessible to all. Further, it mandates the establishment and maintenance of a system of free public education in the elementary and high school levels;

"WHEREAS, pursuant to the above-cited constitutional mandate, and in response to the long-felt needs of our people in the countryside, House Bill No. 9594 was passed authorizing the establishment of Maujao National High School in the Municipality of Bulalacao, Province of Oriental Mindoro;

"WHEREAS, the opening-up of Maujao National High School this coming school year is expected to inspire and encourage both the students and parents of Barangay Maujao and its four adjacent barangays who because of poverty could hardly send their youths to a distant high school;


"WHEREAS, it is sorry to note that the Local School Board and the Municipal Government of Bulalacao were both exhausted of funds that the realization of a cherished dream


of a public high school in the district cited above lies on the assistance of the good congressman; Now, therefore, be it

Andaya, Congressman, 2nd District, Oriental Mindoro to allocate funds for the salary and other emoluments of one teacher in soon to be opened Maujao National High School in the Municipality of Bulalacao, Province of Oriental Mindoro in the amount of Two Hundred Fifteen Thousand Nine Hundred Seven Pesos and Sixty Centavos (P215,907.60);


