“WHEREAS, Section 35 of the same law further provides that the local government units may enter into a joint ventures and such other cooperative arrangements with peoples nongovernmental organizations to engage in the delivery of certain basic services, capability building and livelihood projects and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance and enhance the economic and social well-being of the people

“WHEREAS, Mansalay Agriculture and Fisheries Development Cooperative (MAFDECO) based in Roxas, Oriental Mindoro was established to foster cooperativism, promote mutual understanding and cooperation geared towards the upliftment of social and economic status of its members;

"WHEREAS, MAFDECO was duly registered with the Cooperative Development Authority under Registration No. 9520-04002657 on November 17, 2009 to which after proper evaluation and assessment of the pertinent documents submitted pursuant to Ordinance No. 4, series of 1992, this Sanggunian finds no reason not to accredit the cooperative; Now, therefore, be it


