DISTRICT OFFICE, ROXAS, ORIENTAL MINDORO TO INSTALL TRAFFIC
WARNING SIGNAGES ALONG THE NATIONAL ROAD FROM BULALACAO,
ORIENTAL MINDORO TO MAGSAYSAY, OCCIDENTAL MINDORO

“WHEREAS, the national road from Bulalacao, Oriental Mindoro to
Magsaysay, Occidental Mindoro that virtually linked the two provinces of the
Island of Mindoro was finally opened to traffic;

“WHEREAS, because of its progress from being a rugged, dusty/mudd to
a concrete modern highway eventually lead to move vehicles cruising such route;

“WHEREAS, it is sadly observed that most of the vehicular accidents that
occurred along this road was due to the absence or lack of traffic warning
signages particularly in the areas considered as accident prone;

Mindoro to Magsaysay, Occidental Mindoro;


