EARNESTLY REQUESTING THE HONORABLE RODOLFO G. VALENCIA, PROVINCIAL GOVERNOR, PROVINCE OF ORIENTAL MINDORO THROUGH MR. RODOLFO VALDEZ, PROVINCIAL AGRICULTURIST TO GRANT TWENTY (20) UNITS OF SHALLOW TUBE WELLS FOR THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the provision of shallow tube wells by the Department of Agriculture to the marginal farmers of this Municipality last year proved to be beneficial for it helped overcome the problem of the deficiency in water supply due to the absence of an effective irrigation system;

"WHEREAS, sufficient water supply for the production of various agricultural products such as rice, garlic, vegetables and other varieties of cash crops is the most important factor for the increased farmers yield in the previous year;

"WHEREAS, considering the positive results of the provision of shallow tube wells, additional units are absolutely necessary especially this summer season when water becomes too scarce which might decrease agricultural production;


"WHEREAS, it is learned that the Provincial Government has on its hands several units of shallow tube wells which are ready for distribution; Now, therefore, be it


