RESOLVED AS IT IS HEREBY RESOLVED, To: Re-set the date of the public auction for the exclusive rights on May 15, 2006 at 3:00 o'clock in the afternoon, in case of failure, the second and final bidding is hereby likewise set to be held ten (10) days thereafter;

RESOLVED FURTHER, To: Fix the floor price for each zone in the following manner; to wit:

Zone I- From Cufasi point to Buyayao point - Php20,000.00

Zone II-From Buyayao point to Binanawang point - Php50,000.00

Zone III- From Maasin point to Loboc point (including Kaburayan River) – Declared as Fish Sanctuary

Zone IV- From Kaburayan River to Tambi-tambi point - Php40,000.00

Zone V- From Tambi-tambi point to Mangusing point - Php50,000.00

Zone VI- From Mangusing point to Burungcaan point – Php40,000.00






