AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH DAYANGHIRANG SURVEYING AND DEVELOPMENT OFFICE AT ROXAS, ORIENTAL MINDORO REPRESENTED BY ENGR. RODOLFO V. DAYANGHIRANG FOR THE ROUTE AND TOPOGRAPHIC SURVEY OF CAWACAT TO BALATSAN BARANGAY ROAD IN VIEW OF THE TWO (2) CONSECUTIVE FAILED BIDDINGS THEREOF AND RATIFYING THE SAME CONTRACT

"WHEREAS, Cawacat to Balatasan Barangay Road was included under the projects funded by the Infrastructure for Rural Productivity Enhancement Sector (INFRES) Program of the Department of Agriculture upon coordination with the Local Government Unit concerned;


