RESOLUTION REQUESTING MUNICIPAL MAYOR OF BULALACAO, ORIENTAL MINDORO, ENGR. ERNILO C. VILLAS TO APPROPRIATE FUNDS FOR THE CONSTRUCTION OF DRAINAGE CANAL FROM BARANGAY PROPER GOING TO THE SHORE IN BARANGAY MAASIN, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao is well-nigh to being an agro-eco-tourism destination in the Province of Oriental Mindoro, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;
