“WHEREAS, Bulalacao is well-nigh to being an agro-eco-tourism destination in the Province of Oriental Mindoro, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, the Local Government Unit of Bulalacao is focused and steadfast in improving the agricultural development and economic advancement of the municipality as a whole by doing road infrastructure projects that are beneficial to its people, hence, it is planning to construct farm-to-market roads from Sitio Tara to Sitio San Vicente both in Barangay San Juan;
