"WHEREAS, Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities, as such for municipalities, it includes health services which include the implementation of programs and projects on primary health care by purchasing medicines, medical supplies, and equipment needed to carry out the health services;

"WHEREAS, Bulalacao, a 3rd class municipality hounded with financial constraints which is located at the southernmost tip of the Province of Oriental Mindoro, has 15 barangays with a total population of 44,336 based on the 2020 census, and has a municipal government that has a paramount objective to uplift the general health condition of the people by providing better medical facilities and services;


"WHEREAS, most of the sitio and barangay health centers of this municipality are lacking of primary medical equipment such as blood pressure apparatus and weighing scale, some of which are already not functioning due to oldness;


"WHEREAS, this Sanggunian is humbly asking the good Governor Humerlito "Bonz" A. Dolor to provide assistance by granting the abovementioned equipment to the necessitous barangays of this municipality; Now, therefore, be it...
