

RESOLUTION NO. 11
ORDINANCE NO. 3

AN ORDINANCE AMENDING RESOLUTION NO. 39, ORDINANCE NO. 11, SERIES OF 1977 DECLARING F. ATIENZA STREET (NORTHWEST OF TOWN PROPER) AND A SALAS STREET (NORTHEAST OF THE TOWN PROPER) ONE WAY TO ALL JEEPNEYS, BUSES, AND OTHER 4 WHEELED VEHICLES ENTERING AND LEAVING THIS MUNICIPALITY.

By virtue of the power vested to Sangguniang Bayan under PD 477 and section 5, PD 826, be it enacted by the Sangguniang Bayan of Bulalacao, Oriental Mindoro.

T h a t

SECTION 1. F. Atienza Street (Northwest of the town proper) is hereby declaring One Way to all jeepneys, buses, and other 4 wheeled vehicles entering Poblacion of Bulalacao, Oriental Mindoro and A. Salas Street (Northeast of the town proper) One Way to all jeepneys, buses and other 4 wheeled vehicles leaving this Municipality.

SECTION 2. One Way signboard should be placed in the respective streets mentioned in Section 1 hereof;

SECTION 3. Violation of this Ordinance shall be punished by fine of not less than FIFTY (₱50.00) PESOS to TWO HUNDRED (₱200.00) PESOS or both such fine at the discretion of the court.

SECTION 4. An Ordinance or Ordinances in conflict and or inconsistent with the provisions of this Ordinances shall be null and valid.

SECTION 5. This Ordinance shall take effect immediately.

RESOLVED, that copies of this Resolution be furnished the Station Commander Bulalacao, Oriental Mindoro for implementation.


