ORDINANCE NO. 05-06-050

DECLARING ALL THE WATERSPRINGS FOUND AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AS WATERSHED AREAS

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Declaration of Policy. It is hereby declared the policy of the Municipality that the maintenance and preservation of a sound ecological balance and clear environment are salient concerns that shall enjoy genuine and meaningful local autonomy to enable it to attain their fullest development and self-reliant communities and make them an effective partners in the attainment of national goal. In this regard, the Municipality of Bulalacao, Province of Oriental Mindoro hereby recognizes the following powers over environment as provided for under Section 17 par (ii) of R. A 7160 otherwise known as the Local Government Code of 1991 which mandates the Municipality to endeavor itself or:

- i. Implement community-based forestry projects, including social forestry programs and similar projects;
- ii. Control of communal forests;
- iii. Establish tree parks, greenbelts and similar forest development projects;
- iv. Create environmental management system.




