RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 1 ✓

ORDINANCE NO

REQUIRING PERSONS, CORPORATIONS, ASSOCIATIONS AND COMPANIES TO PAY ₱5.00 FOR EVERY COURT CLEARANCE ISSUED BY THE MUNICIPAL JUDGE AND SHALL PROVIDE FINES AND PUNISHMENT FOR EVERY VIOLATION THEREOF

WHEREAS, the former rate of Court clearance issued by the Municipal Judge of this town is only ₱2.00;

WHEREAS, considering the high cost of supplies and materials, this two pesos is not enough to meet the demand of same;

WHEREAS, former rate of court clearance in this Municipality is the lowest as compared to other Municipalities;

WHEREAS, in order to regulate the rate of Court Clearance in this Municipality, the Sangguniang Bayan hereby ordains, that:

SECTION 1.- All persons, Corporations, Associations and Companies are hereby required to pay the amount of ₱5.00 in the Office of the Municipal Treasurer for every Court Clearance issued by the Municipal Judge;

SECTION 2.- No Court Clearance shall be issued to the above without paying the corresponding amount mentioned in Section 1, hereof;

SECTION 3.- Violation of this Ordinance or parts hereof, shall be fined the amount of ₱50.00 to ₱200.00 or an imprisonment of 10 to 30 days or both such fine and imprisonment at the discretion of the Court;

SECTION 4.- Ordinance or Ordinances inconsistent with the Provisions of this Ordinance are repealed or modified accordingly;

SECTION 5.- This Ordinance shall take effect immediately after its passage;

UNANIMOUSLY APPROVED

There no having no other business to be transacted so motion of Hon. Amparo S. Gregorio, seconded by Hon. Ulpiano C. Pandino, the session was adjourned at 12:00 o'clock in the morning.
