"WHEREAS, Section 106 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian. For the purpose, the development council shall assist the corresponding sanggunian in setting the direction of economic and social development and coordinating development efforts within its territorial jurisdiction;

"WHEREAS, item 3.7 of Local Budget Circular No. 140-A, dated March 29, 2022 states that "In case the PPAs and expenses are not among those included in the approved AIP, the Local Development Council (LDC) shall prepare a supplemental investment program for the purpose to be approved by the local sanggunian";




