REQUESTING THE REGIONAL DIRECTOR, DEPARTMENT OF EDUCATION, CULTURE AND SPORTS, REGION IV TO PRIORITIZE THE BULALACAO NATIONAL HIGH SCHOOL, BULALACAO, ORIENTAL MINDORO IN THE GRANT OF COMPUTER MACHINES

"WHEREAS, it is a Constitutional mandate that the State shall assign the highest budgetary allocation to education and that basic education be made available to all;

"WHEREAS, the Bulalacao National High School at the Municipality of Bulalacao, Oriental Mindoro lacks the necessary facilities and amenities that the modern technology offers;

"WHEREAS, it is learned that the Department of Education, Culture and Sports are giving computer machines to different secondary schools to which the Bulalacao National High School wish to be included and granted with such necessary facility which is believed to enhance students' potentials and capabilities;

"WHEREAS, the abovementioned secondary school is in need of five (5) units of computer for the furtherance of education because better and quality education is seen to be a solution to the crumbling economy and moral degradation of the country; Now, therefore, be it


