**SPECIAL ORDINANCE NO. 04-12-13**

AMENDING SPECIAL ORDINANCE NO. 04-11-11 ENTITLED "SPECIAL ORDINANCE CREATING AND DETERMINING CERTAIN POSITIONS IN THE MUNICIPALITY OF BULALACAO IN PERMANENT STATUS IN THE LOCAL GOVERNMENT UNIT OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO AND ALLOCATING THE NECESSARY FUNDS THEREFOR IN THE MUNICIPAL ANNUAL BUDGET, FY 2005 AND THE YEARS THEREAFTER", BY WAY OF CHANGING THE NOMENCLATURE OF CERTAIN POSITIONS

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** Sec. 2 of Special Ordinance No. 04-11-11 is hereby amended to read as follows:

"Sec. 2. REGULATED ACTS. Upon the conferment of the powers mentioned above, the Sangguniang Bayan commits to the long term and focus on a sustainable future for our constituents but also to our workers; thus, this Sangguniang Bayan as a collegial Body hereby Creates as it is hereby creating the following position, viz:









**SEC. 2.** The following positions are hereby abolished:

7. Data Entry Machine Operator-1 - Municipal Health Office


**SEC. 3.** Appropriation for their salaries and other emoluments shall be allocated by the Municipal government starting FY-2005 and the years thereafter,


